**Notification**

In exercise of Powers conferred under Article 166 (3) of the Constitution of India, The Governor of Bihar is pleased to make following amendments in the Rules of Executive Business 1979 (as amended from time to time).

**Rules of Executive Business (Amendment) 2006**

1-Short title, Extent and commencement :-

1. These Rules may be called the Rules of Executive Business (Amendment) 2006.
2. It shall extend to the whole of the state of Bihar.
3. It shall come into force at once.




