

Tender Notice

Sealed tenders are invited from Manufacturer, their authorized dealers', DGCA approved Companies/ Firms/ Public Enterprises for Purchase of Three Brand new engines (not overhauled not rebuilt) Lycoming IO-360-L2A fitted in Cessna-172 R on Standard Exchange Basis.

1. The tender must reach the Chief Flight Instructor, Bihar Flying Institute, Airport, Patna on or before 22.08.2016 at 05:00PM.
2. Bidders shall submit their offer in two separate sealed envelopes labeled as **Technical Bid** and **Financial Bid**. These two bids shall be kept in another big envelope which should be sealed and subscribed, '**Tender for Purchase of Cessna-172 R engines**.
 - a. Technical Bid should contain specification of engines, authorization certificate from manufacturer company/DGCA, Certificate that the Company has not been black listed by Government Organization/ DGCA. Income Tax Return of previous year. A Bank Draft of Rs 50,000/- (Rs. Fifty thousand) as security money payable to Director-cum-Chief Pilot, C. A.D, Govt. of Bihar, Patna.
 - b. Financial Bid should contain the door delivery (at Patna BFI Hangar) charges of per engine inclusive of all taxes and transportation charges, validity of the rate and transporting the Core exchange item from Patna to manufacturer company. Financial bid will be opened only of those tenderer whose technical bid will be found in order.
3. Security money of Unsuccessful bidders will be refunded immediately after final selection.
4. The Technical bid and Financial bid of the tender will be opened on 24.08.2016 and 26.08.2016 at 03:00 PM. before the committee headed by Principal Secretary, Cabinet Secretariat Department, Bihar, Patna at his official chamber or by an officer/committee so authorized by him before bidders/authorized representatives.
5. The successful bidder will have to sign an agreement as per financial rule and will have to deposited security money @ 5% of the total amount of the order in the shape of Bank Guarantee from Commercial Bank or A/c payee Demand Draft prior to issuance of purchase order. In case of any dispute matter will be decided in the High Court Judicature at Patna.
6. The Principal Secretary, Cabinet Secretariat Department, Bihar reserves the right to reject / cancel any / all tenders without assigning any reason thereof.
