
**Tender Notice**

Sealed tenders are invited for the supply of one twin engine Helicopter from DGCA NSOP approved company/organization on hire basis for six Months or till the State Government Helicopter Dauphin SA365N VT-LNU becomes operational for Govt. of Bihar VIP/VVIP movement. The Helicopter should have following specifications –

1. The make of helicopter should not be more than 5 years/ 7 years.
2. Helicopter should be 5/7 seater excluding Pilot and co-pilot
3. Helicopter should be ready for flying on 24x7 days basis.
4. It should be completely air-conditioned.
5. Replacement of helicopter should be made with a helicopter having same capacity and specification in case the supplied helicopter gets grounded.

**Terms and Conditions**

1. The tender must reach the Joint Secretary, Cabinet Secretariat Department, Old Secretariat Building, Patna on or before 27-10-14 at 5:00 P.M.
2. Financial bids of seven year old helicopter will be opened only when tender of five year old helicopters are not considered. Preference will be given to five years old seven seater (excluding crew member) Helicopter.
3. Bidders shall submit their offer in two separate sealed envelopes labelled as Technical Bid and Financial Bid. Separate Technical and Financial bid shall be submitted for five years and seven years old helicopters. These two bids shall be kept in another big envelope which should be sealed and subscribed, 'Tender for Helicopter on hire basis'.
  - a. Technical Bid should contain a Bank Draft amounting to ₹ 1,00,000.00 (₹ One Lakh) only as security money payable to Director-Cum-Chief Pilot, Directorate of Civil Aviation, Govt. of Bihar Patna. Security money of unsuccessful bidders will be refunded immediately after final selection. The technical aspect of helicopter should also be mentioned as follows in Technical Bid.-
    - (i) Type of Helicopter
    - (ii) Seating capacity.
    - (iii) Cruising speed and endurance
    - (iv) Year of manufacturing
    - (v) Pilot's Qualification to carry out VIP/VVIP task as per DGCA norms.
    - (vi) Valid Certificate i.e. ARC, C of R., NSOP etc.
  - b. Financial bid should contain the rate quoted for monthly hiring of Helicopter inclusive of all charges i.e. boarding, lodging & transportation charges of Crew members and should also separately mention tax payable on the hiring charges. Financial bid will be opened only of those tenderer whose technical bid will be found in order.
4. Technical bid of the tender will be opened on 28.10.14 at 3:00 P.M. before the committee headed by Principal Secretary, Cabinet Secretariat Department, Bihar, Patna or by an officer so authorized by him before representatives of Companies / Organization and Public enterprises.
5. The selected contractor shall have to place the helicopter at Patna base immediately after receipt of the work order and have to provide helicopter for full month on 24X7 basis. In case the helicopter gets grounded alternate helicopter of the same capacity and standard with crew members shall have to be provided by the contractor. No extra payment will be made for alternate helicopter.
6. If contractor fails to provide the helicopter on any day, penalty at prorata basis of the stipulated monthly flying will be deducted from the bill.
7. The selected eligible Company / Organization / Public enterprise shall have to furnish an agreement as per rules and have to deposit security money @ 5% of the total order value for the contract period in the shape of bank guarantee prior to issuance of order.
8. In case of any dispute, the place of settlement will be within the jurisdiction of High court, Patna.
9. The Principal Secretary/Secretary, Cabinet Secretariat Department, Bihar reserves the right to reject / cancel any / all tenders without assigning any reason thereof.
