

Tender Notice

Sealed tenders are invited from DGCA approved Companies/ Firms/ Public Enterprises/Individuals for outsourcing the services of Quality Manager and Continuing Airworthiness Manager having A & C license on Cessna 172R Aircraft, presently operated by Bihar Flying Institute. All works will be performed at Patna base only.

1. The tender must reach the Chief Flight Instructor, Bihar Flying Institute, Civil Aviation Directorate, Airport, Patna on or before 21-06-2012 at 4:00PM.
2. Bidders shall submit their offer in two separate sealed envelopes labeled as Technical Bid and Financial Bid. These two bids shall be kept in another big envelope which should be sealed and subscribed, **'Tender for outsourcing the services of Quality Manager and Continuing Airworthiness Manager.**
 - a. Technical Bid should contain qualification and work experience details separately that of QM and of CAM, age, no objection certificate from the company/firm, Income Tax Return of previous year, certificate that the QM/CAM has not been punished during his previous assignments i.e., suspension of licence or adverse remarks given by DGCA/Organization. A Bank Draft of Rs 10,000.00 (Rs. Ten thousand) as security money payable to Director – Cum- Chief Pilot, C.A.D, Govt. of Bihar, Patna.
 - b. Financial Bid should contain total monthly charges including boarding, lodging and transportation charges and all taxes. Financial bid will be opened only of those tenderer whose technical bid will be found in order. The QM/CAM will be stationed at Patna and will have to provide service from 8AM to 10PM every day excluding Sunday only.
 - c. Separate bids should be submitted for QM/CAM. The rates quoted must be valid till 31.07.2013.
3. Security money of Unsuccessful bidders will be refunded immediately after final selection.
4. The tender will be opened on 21-06-2012 at 5:00 PM before the committee headed by Principal Secretary, Cabinet Secretariat Department, Bihar, Patna or by an officer so authorized by him before bidder's representatives.
5. The Successful tenderer will have to sign an agreement as per rules.
6. If the contractor fails to provide the service within the stipulated time penalty at the rate of 5% of the total monthly charges will be deducted per day.
7. In case of any dispute the matter will be decided in the High Court of Judicature at Patna.
8. The Principal Secretary, Cabinet Secretariat Department, Bihar reserves the right to reject / cancel any / all tenders without assigning any reason thereof.
