## **Tender Notice**

Sealed tenders are invited for Twin engine minimum seven seater (excluding Pilot and Co Pilot ) and maximum of five years old Helicopter from DGCA approved firm/operator for the supply of One helicopter on monthly hire basis for Government of Bihar VIP/VVIP Movement.

## **Terms and Conditions**

- 1. The tender must reach the Director (Operation), Civil Aviation, Panta, Airport Patna on or before 04.05.2012 at 3:00 P.M.
- 2. Bidders shall submit their offer in two separate sealed envelopes labelled as Technical Bid and Financial Bid. These two bids shall be kept in another big envelope which should be sealed and subscribed, 'Tender for Helicopter on hire basis'.
  - Technical Bid should contain a Bank Draft amounting to Rs 1,00,000.00 (Rs. One Lakh) only as security money payable to Director-Cum-Chief Pilot, Directorate of Civil Aviation, Govt. of Bihar Patna. Security money of Unsuccessful bidder will be refunded immediately after final selection. The technical aspect of helicopter should also be mentioned as follows in Technical Bid.-
    - (i) Type of Helicopter
    - (ii) Seating capacity.
    - (iii) Cruising speed and endurance
    - (iv) Year of manufacturing
    - (v) Pilot's Qualification to carry out VIP/VVIP task.
    - (vi)Valid Certificate i.e. C of A Certificate, C of R. etc.
  - b. Financial bid should contain the rate quoted for monthly hiring of Helicopter inclusive of all charges i.e.boarding, lodging & transportation charges of Crew members and should also separately mention tax payable on the hiring charges. Financial bid will be opened only of those tenderer whose technical bid will be found in order. Validity of rate should be till 31 May, 2013.
- The tender will be opened on 04.05.2012 at 5:00 P.M. before the committee headed by Principal Secretary, Cabinet Secretariat Department, Bihar, Patna or by an officer so authorised by him before representatives of Companies / firms and Public enterprises.
- The selected contractor shall have to provide helicopter for full month on 24X7 basis. In case the helicopter gets grounded alternate helicopter of the same size and standard with crew members shall have to be provided by the contractor.
- 5. If contractor fails to provide the helicopter, penalty at the rate of one hour hiring charges per day will be deducted for the monthly bill.
- The selected eligible Company / Firm / Public enterprise shall have to furnish an agreement and deposit security money @ 5% of the total order value for the contract period in the shape of bank guarantee prior to issuance of order. In case of any dispute, the place of settlement will be within the jurisdiction of Patna.
- 7. The Principal Secretary, Cabinet Secretariat Department, Bihar reserves the right to reject / cancel any / all tenders without assigning any reason thereof.
