Tender Notice

Sealed tender is invited from manufacturers or DGCA's approved firms/Companies/Public enterprises for Purchase of Spare Parts and consumable items of Dauphin SA365N, VT-ENU helicopter as per the following:-

9. The tender must reach to Director- Cum- Spl. Secretary, Civil Aviation Directorate, Airport Patna on or before **5th Oct., 2017 at 05:00 PM.**
10. Bidders Shall Submit their offer in two separate sealed envelopes one as technical Bid and other as Financial Bid. These two bids shall be kept in another big envelope which should be sealed and subscribed, 'Tender for supply of Spare Parts and consumable items of Dauphin SA365N, VT-ENU helicopter.
 - a. Technical Bid should contain No dues certificate of GST, Photo copy of DGCA'S/ Manufacturers approval certificate, Certificate that the Company has not been black listed by Public Sector undertaking/Government Organization/DGCA, Income Tax Return of previous year, a Bank Draft of Rs 50,000.00 (Rs. Fifty Thousand) as security money payable to Director-Cum-Chief Pilot, Directorate of Civil Aviation, Govt. of Bihar Patna.
 - b. Financial Bid should contain the rate of outright New, Rate of overhauled, Rate of outright new with exchange, Rate of overhauled with exchange. for rotatable spare parts. Validity of the rate and Guarantee/ warranty Period. The quoted rate should be that of door delivery i.e. Civil Aviation (Bihar Hangar) Campus at Patna. Rate should be quoted in Indian Rupees (₹) only. If it is quoted in foreign currency payment will be given on R.B.I. exchange rate of the foreign currency of the date of invoices. Financial bid will be opened only of those tenderer whose technical bid will be found correct.
11. Security money of Unsuccessful bidders will be refunded immediately after final selection.
12. The Technical bid and Financial bid of the tender will be opened on **6th Oct., 2017 and 10th Oct., 2017 at 3:30 PM** respectively before the committee headed by Principal Secretary, Cabinet Secretariat Department, Bihar, Patna at his official chamber or by an officer so authorized by him before bidders/authorized representatives.
13. In case of any dispute, the place of settlement will be within the Judicature of High Court at Patna.



14. The Principal Secretary, Cabinet Secretariat Department, Bihar reserves the right to reject / cancel any / all tenders without assigning any reason thereof.
15. The tender notice and details of spares parts can be seen on this Department's website "www.csd.bih.nic.in"
16. Spare Parts supplied by company must have up to date serviceable tag and FAA tag. The items received with old serviceable tag and FAA tag will not be accepted and returned back to the company at their own cost. Consumable items such as oil, grease, paint should have minimum 70% valid serviceable life on receipt in the store. The items not meeting above mentioned requirement will be returned back to the supplier at their own cost.
