
Tender Notice

Sealed tenders are invited from DGCA CAR145 approved Companies/ Firms/Public Enterprises for outsourcing the maintenance of Government plane King Air C-90 A/B, for a period of two years from the date of Agreement, presently operated by Government of Bihar for VIP flying. All works will be performed at Patna base only. The maintenance comprises all phase inspections as per maintenance programme, TBO,SIL, all type of SB, AD, modification, snag rectification all type of Radio, Navigation and instrument works, MBT, bench check of instruments, CT, Periodic check of battery, NRL and fee of DGCA arising from manufacturer/ DGCA requirement.

1. The tender must reach the Director (Operation)- cum- Chief Pilot, Civil Aviation Directorate, Airport, Patna on or before **18.07.2017 at 05:00 PM.**
2. Bidders shall submit their offer in two separate sealed envelopes labeled as Technical Bid and Financial Bid. These two bids shall be kept in another big envelope which should be sealed and subscribed, **'Tender for maintenance of King Air C-90/AB Aircraft VT-EBG S/N- LJ1752.**
 - a. Technical Bid should contain qualification and work experience details of Maintenance Engineer and other Technical Staffs.No objection certificate from the company/firm, Income Tax Return of previous year, proof of annual turnover along with audited financial statement of last three years.
 - b. Company should have minimum three years' experience of King air C-90 A/B aircraft for VIP/VVIP aircraft.
 - c. AME/Technical staff should have regular VIP/VVIP maintenance experience on King Air C-90.
 - d. Company should have standby maintenance support such as an experienced engineer having minimum maintenance experience of Ten years or above as type rated AME so that maximum utilization of Govt. Aircraft King Air C-90 A/B can be achieved in event of defect rectification.
 - e. Security money of Rs 25000 should be deposited as Bank Draft by the bidders.
 - f. Financial Bid should contain the monthly charges including boarding, lodging and transportation charges and all taxes, validity of the rate. Financial bid will be opened only of those tenderer whose technical bid will be found in order. Maintenance Engineer and Staff will be stationed at Patna and will have to provide service on 24X7 basis. The rate quoted must be valid till six months from date of quotation.
3. Security money of Unsuccessful bidders will be refunded immediately after final selection.

4. The tender will be opened on **20.07.2017 at 04:00 PM** before the committee headed by Principal Secretary, Cabinet Secretariat Department, Bihar, Patna or by an officer so authorized by him before bidder's representatives.
5. The Successful tenderer will have to sign an agreement as per rules. Any violation of agreement will be deemed to be a breach of contract and accordingly legal action will be taken.
6. The successful bidder will have to obtain approval of Patna base within ten days from the date of award of contract. The awardees company will have access to hangar facility and available tools but if any tool, which is not available, the concerned company will have to bring the tool from their own sources for which no extra payment will be given. The list of available tools can be seen on department's website.
7. If the Contractor/Individual fails to provide the service within the contract period, penalty at the rate of 1% of the total monthly charges will be deducted per day.
8. In case of any dispute the matter will be decided in the High Court of Judicature at Patna.
9. The Principal Secretary, Cabinet Secretariat Department, Bihar reserves the right to reject / cancel any / all tenders without assigning any reason thereof.
10. Apart from above said maintenance work the major work like overhaul of main and nose landing gear, overhaul of both propellers and replacement of both wind shield glasses will be falling due in the month Feb, 2018. A separate tender process will be followed by Govt of Bihar for completion of work.
