Tender Notice

Sealed tenders are invited from Manufacturer and DGCA approved organisation for repair and reconditioning of Main Rotor Blades Qty-04 installed on Govt. Helicopter Dauphin SA365N, VT-ENU, Sl. No.-6073. All works will be performed in-situ i.e. Patna base only. All the necessary spares, consumable and tools will be provided by the contractor.

1. Pre bid meeting will be held on 12.12.2018 at 3:30 PM in the office of the Principal Secretary, Cabinet Secretariat Department. Where a presentation will be given by the bidder regarding the said work.
2. The tender must reach to Director (Operation)- Cum- Chief Pilot, Civil Aviation Directorate, Airport Patna on or before 24.12.2018 at 3:30 PM.
3. Bidders Shall Submit their offer in two separate sealed envelopes labelled as Technical Bid and Financial Bid. These two bids shall be kept in another big envelope which should be sealed and subscribed, 'Tender for repair and reconditioning of 04 main rotor blades of Govt. helicopter Dauphin SA365N, VT-ENU, Sl. No.6073.
4. Technical Bid should contain qualification and work experience details of Maintenance Engineer and other Technical Staffs. No objection certificate from the company/firm, Income Tax Return of previous year, proof of annual turnover along with audited financial statement of last three years.
5. Security money of Rs 1,00,000 (One lac) should be deposited as Bank Draft by the bidder in favour of Director-Cum-Chief Pilot, Civil Aviation Directorate, Govt. of Bihar Patna.
6. Financial Bid should contain the total charges including boarding, lodging and transportation charges and all taxes. Financial bid will be opened only of those tenderer whose technical bid will be found in order. The rate quoted must be valid for six months from the date of quotation.
7. Security money of unsuccessful bidders will be refunded immediately after final selection.
8. The tender will be opened on 27.12.2018 at 3:30 PM before the committee headed by Principal Secretary, Cabinet Secretariat Department, Bihar, Patna or by an officer so authorized by him in presence of Bidders/authorized representatives.
9. The successful tenderer will have to sign an agreement as per rules. Any violation of agreement will be deemed to be a breach of contract and accordingly legal action will be taken.
10. If the Contractor/Individual fails to provide the service within the contract period, penalty at the rate of 1% of the total charges will be deducted per day.
11. In case of any dispute the matter will be decided in the judicature of Patna High Court, Patna.
12. The Principal Secretary, Cabinet Secretariat Department, Bihar reserves the right to reject / cancel any / all tenders without assigning any reason thereof.
