

**Tender Notice**

Sealed tenders are hereby invited from DGCA CAR 145 approved Companies/firms/public enterprises for maintenance of the Dauphin SA-365N Govt. helicopter installed with Arriel -IC engines as per Maintenance programme TBO replacement, SB and AD compliance, Required Modification, Bench Check of Instruments, MBT, SOAP test, Battery C.T., radio inspection, certification, Defect rectification, non schedule and any required servicing, preservation and De-preservation of the helicopter and it's engines, all the scheduled inspection falling due within the contract period as per DGCA requirement will be completed by the contractor. The contract period will be for 02 yrs.

1. The tender must reach the Administrative Officer., Civil Aviation Directorate, Govt. of Bihar, Patna, Airport Patna on or before **03.03.2020 at 05:00 PM.**
2. Pre bid meeting and physical survey of helicopter will held on **28.02.2020 at 03:00 PM.**
3. Bidders shall submit their offer in two separate sealed envelopes labelled as Technical Bid and Financial Bid. These two bids shall be kept in another big envelope which should be sealed and subscribed "Tender for Maintenance of Dauphin SA-365N Govt. Helicopter Reg.no.- VT-ENU installed with Arriel-IC engines for 02 years
4. **Technical Bid should contain the following.**
  - a. The company/Firms/public enterprises should have experience not less than 05 years for Maintenance of multi engine Helicopter. They are also required to submit qualification and Experience details of Engineers and other Technical Members indicating experience of according to DGCA rules/circulars.
  - b. Service condition of Engineers and other Technical Members, i.e. whether they are on regular pay roll or on contract basis. If on contract basis the period of contract should be clearly indicated in writing with their NOC.
  - c. A bank draft/ bankers cheque amounting Rs 50,000/- as security money payable to Bihar Flying Inst. C.A. Department, Cabinet Secretariat Department, Patna. Security money of unsuccessful bidders will be refunded immediately after the final selection.
  - d. AME Should have licence as per CAR66 category C and B2.
  - e. An affidavit under Oath to be submitted by the company stating that company is not blacklisted by DGCA/ any other State Govt/contracting agencies.
5. **Financial bid** should contain price inclusive of all work scope coverage, freight charges, out station work charges, fooding lodging and all taxes. The rate quoted for monthly charge for Maintenance of the helicopter. Quotation should be submitted for include boarding, lodging and transportation charges of engineers and Technical members. Financial bid will be opened only of those tenderer whose technical bid found in order.
6. The tenders of Technical and Financial bid will be opened **on 05.03.2020 at 12:00 Noon.** before the committee headed by Principal Secretary, Cabinet Secretariat Department, Bihar, Patna or by an officer so authorized by him in presence of the representative of companies/ Firms/Public enterprises.
7. The selected contractor shall have to provide maintenance of the helicopter on 24X7 basis. Adequate number of fully qualified Engineers and other Technical members are required as per DGCA rules and to be stationed at Patna during the period of contract.
8. If the contractor fails to provide the service at any day or days, penalty at the rate of twice the per day charges payable and calculated on prorata basis will be deducted.
9. Selected Company should be responsible to obtain base approval within 15 working days from the date of awarded contract.
10. The selected eligible Company/firm/ Public enterprises shall have to furnish an agreement as per rules. In case of any dispute, the place of settlement will be within the judicature of High Court at Patna.
11. The Principal Secretary, Cabinet Secretariat Department, Bihar reserves the right to reject/ cancel any/ all tenders without assigning any reason thereof.
