## **Tender Notice**

Sealed tender is invited from DGCA's approved firms/Companies/Public enterprises for servicing of King Air C-90 (VT-EFG, L J-719) including all phase inspection and renewal of C of A / ARC, Structural Inspection, Overhaul of Landing Gear, propeller, repair/replacement of autopilot with latest model, overhaul of all instruments, Radio and navigation equipments and all other systems/equipment fitted in Aircraft, CG calculation and in depth inspection of both engines and its TBO items to restore these engines in airworthy condition as specified by manufacturers/ DGCA requirement. Refilling and replacement of oxygen Cylinder, Fire Extinguisher replacement, Refinishing/Painting of interior as well as exterior of complete Aircraft, Re-weighment of aircraft and any other required inspection as per Manufacturer and DGCA requirements. All applicable SB, AD Mod & TBO items for restoration of C of A/ARC and cabin Airconditioning and Pressurization will also be done by the bidder. Aircraft is awaiting for C of A/ARC renewal since November-2009. All required spares and consumables should be supplied by the party performing work on this aircraft.

The tender must reach to Director- Cum- Spl. Secretary, Civil Aviation Directorate, Airport Patna on or before 26.03.19 at 05:00 P.M.

- Bidders Shall Submit their offer in two separate sealed envelopes one as technical Bid and other as Financial Bid. These two bids shall be kept in another big envelope which should be sealed and subscribed, "Tender for repair and renewal of C of A /ARC of Government Aircraft King Air C-90 VT-EFG."
  - a. Technical Bid should contain No dues certificate of CST, Photo copy of DGCA (CAR145) approval certificate, Certificate that the Company has not been black listed by Public Sector undertaking/Government Organization/ DGCA. Income Tax Return of previous year, a Bank Draft of Rs 1,00,000.00 (Rs. One lac) as security money payable to Director-Cum-Chief Pilot, Directorate of Civil Aviation, Govt. of Bihar Patna.
  - b. Financial Bid should contain the cost of the proposed work for repair, overhaul and renewal of C of A/ARC including all above expressed work for repair, cost of Lodging, Boarding and Transportation of required officers and personnel. Rate should be quoted in Indian Rupees (₹) only. Validity of the rate quoted and the warranty period should be given.
- Technical bid of the tender will be opened on 28.03.19 at 03:30 PM before the committee headed by Principal Secretary, Cabinet Secretariat Department, Govt. of Bihar, Patna or by an officer so authorized by him before representatives of Companies / Organization and Public enterprises.
- 4. Security money of Unsuccessful bidders will be refunded immediately after final selection.
- 5. All inspection and repair work including DGCA inspection will be conducted at Patna base.
- 6. Successful bidder (L1) should have to deposit a bank draft of an amount equal to 2.5% of total quoted amount before issue of work order and agreement of work as performance security.
- 7. The Principal Secretary, Cabinet Secretariat Department, Bihar reserves the right to reject / cancel any / all tenders without assigning any reason thereof.

- 9. If bidders feel they can freely approach our QC cell for required technical information in concern with the Aircraft and installed Engine.
- 10. Special Tools and Ground support equipments which are serviceable and available with Govt. of Bihar can be utilized by the contractor free of cost rest all the required specials tools and ground support equipment will be procured by the contractor for which no extra payment will be made.
